LASTE TAEKWONDO

Participation requirement:

All athletes of WT Taekwondo family. Certification of the Geup/Dan grade can be asked on registration. Written consent of the parent or legal guardian is required for the minor contestant, in which they agree for their participation and recognize the outline in all its parts. With the registration, the competitors as well as the clubs accept all points of the outline. The age is to be proved during the registration by presentation of the valid personal ID card or passport.

All Estonian competitors must have ETF License for 2024. This does not apply for foreign competitors.

Age categories:

- Minors 2014-2013 (*head contact agreement of both athletes*)
- Pupils 2016-2015 (no head contact)
- Minis 2018-2017 (no head contact)

Weigh categories:

- Minors M+F: -27, -30, -33, -36, -40, -44, -48, -52, -57,+57kg
- Pupils M+F: -20, -22, -24, -26, -28, -30, -32, -34, -37, -41, +41kg
- Minis M+F: -18, -20, -22, -24, -26, -28, -30, -32, -34, -37, -41, +41kg

(If there are less than 3 participants in a category, categories may be combined. During competition all players must match his age categories).

Fight time:

- Minor 3×60 sec, 60 sec break
 - Pupil 3×60 sec, 60 sec break
 - Minis 3×60 sec, 60 sec break
- Changes on the tournament day possible!*

Competition rules:

The competition rules are based on the actual rules of World Taekwondo. Protest fee 100€. The decision of the referee chairman is final.

Coaches:

1 coach for every 4 athletes. All coaches must be over 18 years of age, dressed in appropriate clothing (training gear, sneakers) and **behaving in a respectful manner.**

Competition information:

The participants shall wear the WT recognized Taekwondo Uniform. Daedo PSS will be used at this Tournament and will be provided by the OC. All athletes must bring their own Daedo sensor socks. Groin/forearm/shin guards and gloves are compulsory and must be brought by the contestants. Mouth piece is compulsory (only white or transparent)! Flexy glass head protector for cadet and kids categories required.

Liability:

All competitors participate at their own risk. With the registration each contestant or her/his guardian agrees explicitly to the exclusion of liability. Promoter and organizer do not accept responsibility for any damages to persons or property! The competitors explicitly accept the current NADA/WADA(National & World Antidoping Agency) code with their registration.

Registration:

The registration must be done by the clubs online on tpss.eu

Deadline 27. september 2024

Total number of participants 75!

With the registration the clubs, competitors and the parents or the legal guardian agrees that they accept the participation and they do know this announcement. Every participant consider that he/she has in a healthy condition and that he/she accepts the rules of this competition.

Registration fee:

15 € per person

50 € per person for competition adding after deadline!

System closes at 27.09.2024 23:59.

Athletes who do not belong to official MNA club of citizenship country pay: 100€ till 27.09.2024. Change of weight categories during weigh-in could be done. The fee is 15€.

Minor constants have to show an agreement of the parents or the guardians during weigh-in to change the category. Single competitors in category could be added to the higher weigh class.

If the athlete registered online does not take part in the competition for some reason, but he/she has not been removed from the list of participants before deadline(27. september 2024) his/her team officially must fully (%100) pay his/her entry fee for the participation.

Data regulations:

We want to let You know that You agree with the registration that we could publish personal data in our purpose. This purpose are according to the rules of Estonian data regulations. We could publish personal data via media and results regarding to this competition. Each participant agrees that his/her names, weight categories, club and country information, results, photos, videos and so on could be published in the internet and in print papers and medias according to the Estonian data regulations.
