RULES

Method of Competiton	Competition will be WT Rules. Single elimination tournament
Seeding	Seniors will be seeded according to February 2025 World Para Taekwondo ranking list.
WT Global Licence	All participants must have a valid 2025 WT Global Licence to participate at this event. Please contact your MNA or club admin to apply for the WT Global Licence
Contest Time:	Para: Best of 3 rounds system (Contest times could be adjusted according to WT TD Decisions)

NOTE: WT Global Licence is mandatory for all age categories

Belt Requirements for Para: WT recognized Dan or 5-1 geup

Protective Equipment & Uniform

The participants shall wear the WT recognized Taekwondo Uniform.
Daedo PSS will be used at this Tournament and will be provided by the OC.

All athletes must bring their own Daedo sensor socks.

All the players must bring their own full equipment except body protector.

Groin/Forearm/shin guards and Gloves are compulsory and must be brought by the contestants.

Mouth guard is compulsory!

Head protector with face shield will be provided by the Organizing Committee.

ACCREDITATION

- Registration will be in the stated Sports Hall.
- Only Team Representative/MNA Official will be allowed to enter in accreditation room.
- Accreditation center will be working between 08:00 – 18:00**

Registration fee will be €150 in this period.**

There will be NO Onsite Registration.

IMPORTANT: If the athlete registered online does not take part in the competition for some reason, but he/she has not been removed from the list of participants/team before **deadline (January 20, 2025)** his/her team officially must fully (%100) pay his/her entry fee for the participation or else athlete/athletes from their team cannot participate in the tournament.

Registration fee payments should be **completed** on January 20, 2025; please consider the SWIFT durations.

Entry Fee and Payment:

Entry Fee – 120 EUR per competitor

Entry fees: The OC shall collect the entry fees from the participating national teams. The national team shall pay an **entry fee by via bank transfer** and the Athletes shall not be allowed to compete without successful payment of entry fee to the Organizing Committee.

Coaches must be at least 18 years old and holder of **Level II WT Para Taekwondon**

Referees

Only International Referees will be accepted. An official invitation for the referees will be sent to all Federations.

Weigh-in

Weigh-in of the contestants shall be completed the day before their scheduled competition.

Weigh in period could be extended or adjusted by WT TD decision accordingly.

Random weigh-in will be published in <http://www.turkiyetaekwondofed.gov.tr/> and <http://www.tpss.eu>. **Random weigh-in athletes that have a weight increase of more than 5% above the weight category where they weighed in will be disqualified.**

During the weigh-in, senior contestants shall wear under pants and female contestants shall wear underpants and brassieres. Underwear will be counted as 100g and deducted from the weight.

Drawing of Lots

Drawing of lots session shall be conducted one (1) day prior to the start of the championships and it will be published in [tpss.eu](https://www.tpss.eu) and <http://www.turkiyetaekwondofed.gov.tr/> and also in WhatsApp Channel.

Classification of Results Individual Awards

Medals will be awarded to the top four athletes in the respective classifications and weight divisions of the pertinent championships:

The medal ceremony will take place IMMEDIATELY after the end of the final fights of certain categories. All fights will take place according to a predetermined schedule.

1st PLACE:	GOLD MEDAL & CERTIFICATE
2nd PLACE:	SILVER MEDAL & CERTIFICATE
3rd PLACE:	BRONZE MEDAL & CERTIFICATE
3rd PLACE:	BRONZE MEDAL & CERTIFICATE

Insurance

The organisation and supervisor assume no responsibility for teams, any damages, violence, loses and injuries during the stay in Turkiye.

All contestants must bring their own documents and forms for any medical treatment in Turkiye. If not, this will have to be paid cash.

First Aid will be provided by the organization and is only to be used in case of an emergency.

Indemnities

The respective national taekwondo associations shall be responsible for ensuring that all officials and participants are covered with effective insurance coverage.

Participants without proper participation entry forms and effective insurance coverage will not be allowed to compete at the championships.

The Organizing Committee will acquire general insurance, at its own expenses, for all participants of the tournament, including but not limited to contestants and staffs, in the event of any injury and/or damages that may arise during the championships.

Roles and RULES

The organizer will keep a register that includes contacts of competitors and members of their entourage, officials and professionals, which will facilitate the identification and monitoring of further contacts of potentially infected persons. The keeping of the register will be in accordance with local legislation and regulations, and in accordance with the protection of personal data. **By accepting the work, volunteering or registering, all participants undertake to give a statement and accept the conditions prescribed by the organizer.**

This rulebook is designed for and binds all participants in the organization who accept the stated instructions by taking over the official accreditation.

Classification

- **Kyorugi (K40)**

International Classification of all Kyorugi (K40 Sport Classes) athletes will take place on February 06-07, 2025.

All teams should prepare their travel for their athletes to be available for International Classification on these dates.

WT Para Taekwondo Department will publish the Classification time schedule after the registration deadline for the tournament.

The details on each sport class can be found in the WT Athlete Classification Rules on the WT website.

Medical Diagnostics Form through World Taekwondo Classification System (WTCS)

Medical Diagnostic Form must be submitted for any NEW (N) or REVIEW (R) athlete registered for the tournament. Deadline for uploading MDFs to the WTCS is on the registration deadline (January 31, 2025).

If no MDF has been submitted by this time the athlete will not be called for classification and cannot compete.

Following IPC Guidelines on data protection concerning athletes and personal classification information, World Taekwondo has in connection with IPC created the World Taekwondo Classification System (WTCS).

World Taekwondo Classification System (WTCS) is the WT online registration tool for MNAs to register their new athletes and add Medical Diagnostic Forms (MDF) and pictures to be seen by the WT Classification Evaluation Committee to determine if the new athlete is eligible for Para Taekwondo and meets Minimum Impairment Criteria (MIC). All athletes in the WTCS will require a WT License Number (GAL).

WTCS Account Policy – Each Member Federation must internally designate exactly one (1) primary user responsible for WTCS Account.
