Random weigh-in

Random weigh-in will be conducted according to WT rules. On the day of the competition, at 07:00 am the randomly selected athletes will be published on the organizer's website and on the OVR's website. Only those athletes selected for the random weigh-in need to be in the venue at 08:00 am.

Competition rules and method

Competition will be held according to WT/WTE Rules and regulations
At the weigh-in every competitor must have identification document with picture. ***GAL LICENCE IS OBLIGATORY (VALID FOR 2025)!***

System of competition

Single elimination tournament system and best of three system.

The Organizing Committee will provide Protector and Scoring System (PSS) and the head protector to the participating contestants. Participating contestants are required to bring their own groin guards, mouthpieces, gloves, sensing socks and shin and forearm guards for their personal use. Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their doboks and protective equipment. Any contestant who wears unofficial doboks or protective equipment will not be permitted to compete.

Restrike Instant Video Replay (IVR) System will be used.

OVR: Taekoplan SenSoft Automation

KPNP Protector and Scoring System (PSS) including PSS Headgear will be used for the competition.

Contest time

Cadets: Rounds of 1,5 minute each with a 1-minute break

Juniors: Rounds of 2 minutes each with a 1-minute break

Condition of participation

Competitors who are not recognized as adults by law in their own country, must send by the parents or lawful guardians signed liability declaration (for accepting the participation and all parts of the official invitation) on kontakt@tkd-zapresic.hr no later than 26th May 2025.

Protest

Protests must be made as per competition rules by the official coach within 10 minutes after the end of the pertinent contest to the Technical Delegate. Each protest fee costs 200,00€ and is non-refundable.

Medical and anti-doping regulations

All medical staff of the respective teams have to apply for a Medical License. Only medical staff that has applied for or is in the possession of a valid CU Medical Licence shall receive an accreditation. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.

Coaches

WT Coach License Level I and valid 2025 WT Global Official License is obligatory for all coaches/trainers and it will be checked. The minimum age of the coach must be 18 years. The trainers **will not be allowed** to enter the competition area.

Liability

All participants take part on their own risk. The organizer is in no way responsible for any damage caused to a person or their belongings. With the registration the participant/club acknowledges and accepts all the listed points.

Seeding

Cadets: All athletes will be seeded according to the latest ETU Ranking available

Juniors: All athletes will be seeded according to the latest ETU Ranking available

Categories - WT world weight categories

Cadets: born in 2011, 2012, 2013. Cadets must hold at least 4th Geup.

Juniors: born in 2008, 2009, 2010. Juniors must hold at least 2nd Geup.

Change of weight category

Change of weight class on day of weigh-in is possible with additional charge of 50,00€.

Awards

Competitors: medals for 1st, 2nd and 3rd place.

Teams: trophies for all cadet categories for 1st, 2nd and 3rd place.

Teams: trophies for all junior categories for 1st, 2nd and 3rd place.

The team ranking is based on the following point system:

1. Every gold medal – 120 points;
2. Every silver medal – 50 points;
3. Every bronze medal – 20 points;
4. 1 point per each contestant who entered the competition area after passing the general weigh-in;
5. 1 point per each win (win by a bye included)

Visa form

To receive the document, you must first be registered for the competition through Simply Compete.

Medical insurance

All participating athletes, coaches and team officials shall have mandatory a medical insurance that covers medical care and in case of emergency repatriation to home country. All relevant documents proving that such insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

Sufficient insurance

The teams are strongly urged and advised to make sure to have their own sufficient travel, cancellation and medical insurance.
