### RULES & REGULATIONS

Competition Rules (WOZ) of the German Taekwondo Union (DTU) shall be applied. Deviations from these competitions rules and special regulations in regard to the competitions rules of the World Taekwondo (WT) require approval from the protest committee at the competition day.  
All participants must be affiliated members of the DTU, ETU or WT.

### METHOD OF COMPETITION

Single elimination, KO-System (Best of 3), Duration of the contest: 3 rounds á 2 minutes with 1 minute break (subject to change in accordance with the WOZ).

### AWARDING/ RESULTS

The Club and Team Awarding can be determined in conclusion of individual results, as following:

- 1 point for the start of each competitor,
- 1 point for the victory of each fight,
- 120 points for 1. place,
- 50 points for 2. place,
- 20 points for 3. place,
- 50 points for uncontested fights

Should two or more Teams have the same amount of points, the result will be determined according to the numbers of Gold, Silver and Bronze medals at first. Afterwards according to the numbers of participants and thereafter according to more points in higher weight divisions.

### IDENTIFICATION

According to the rules & regulations of the German Taekwondo Union all competitors need to have a valid passport.

Members of national federation's affiliation with the ETU are allowed to compete. For countries without any federation being member of the ETU, affiliation with WT is necessary. Upon onsite registration, the contestants must prove their memberships by means of a valid license.

### COACHES

1 coach(es) for every 3 competitors has free admission. A maximum of 4 coaches per team is allowed. The minimum age for a coach must be 18 years old and the coach is only allowed in sportswear & sports shoes with non-marking outsoles

### REFEREES

A quota of at least 50% of all referees should be International or National referees. A quota of 50% or less of all referees can be regional referees.

Food and accommodation (1 overnight stay if the journey is more than 350km) is covered by the organizer. All participating referees receive a fixed rate of 150,00 € (including travel expenses).

**Please confirm your attendance latest by Sunday, 5 October 2025.**

### PROTEST COMMITTEE

The Protest Committee, at least three (3) members, will be appointed by the competition manager (referee director) and chairmen of the committee prior to the start of the competition and should ideally consist of:

- Competition manager (referee director), Chairmen
- DTU Technical Delegate
- T.U.Saar President or his representative

### DECLARATION OF CONSENT

All competitors who are minor (under legal age of 18 years) at the day of the tournament need a declaration of consent by a legal guardian which must be brought to the tournament and presented on request.

### PROTEST

Only the official coach is allowed to protest immediately after the end of the contest. A protest fee needs to be paid for each protest. The decision of protest committee (chairman) is final. (DTU-WOZ, Art. 19.1).

Protest fee: 100 €
