Last updated WT Competition Rules & Interpretation.

Head Kicks

- Class A: 2014, 2015 or 2016: Head kicks are allowed.
- Class B: 2017, 2018 or 2019: **No** head kicks are allowed.

13. METHOD OF COMPETITION

Single elimination, best of three (3) system will be used.

14. CONTEST TIME

Kids divisions: 3(2) rounds of 1 minute, 1-minute break between each round

The WT Technical Delegate has the authority to adjust the contest time as he sees fit.

15. HEAD OF TEAM MEETING/MEDICAL TEAM MEETING

16. GENERAL ELIGIBILITY REQUIREMENTS

Each team/club can send as many athletes as they wish per weight category.

17. ELIGIBILITY REQUIREMENTS

- Member of the team/club of a pertinent Member National Association, recognized by European Taekwondo Union or World Taekwondo (**open for all clubs worldwide**). GAL licence is **not** required
- Belt: **Class A** - at least 4th Geup & Above / **Class B** – at least 6th Geup & Above
Kids: An athlete in order to be eligible for participation must be born in:
Class A: 2014, 2015 or 2016
Class B: 2017, 2018 or 2019

All competitors must prove their age by presenting their passport or identification card at the official weigh in. For those athletes that are not adults, a written letter of consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.

18. COACH ELIGIBILITY REQUIREMENTS

- Minimum age of 18 years.
- WT Coach Certificate **Level I** or above is required.
- Coaches are not allowed to wear Dobok.
- 1 coach per 5 athletes is allowed. Exceeding this ratio is subject to an extra fee.

19. SPORT ENTRIES

Team entries will only be accepted through the Taekoplan online registration:

20. REGISTRATION DEADLINE

4 May 2025, 23:59 CET

This deadline is applicable for all sport entries, payments and admitting all required documents.

21. APPLICABLE FEES

REGULAR ENTRY FEE

75 euro per registered athlete, paid by 4th May 2025.

LATE ENTRY FEE

100 euro per registered athlete, after 4th May 2025.

CASH PAYMENT

150 euro per registered athlete, at the registration desk (**not recommended**).



ON-SITE CHANGE OF MEDAL EVENT (WEIGHT CATEGORY)

50 euro for each weight change after the deadline. Change of weight category it's only possible at registration before general weigh in.

ADDITIONAL ACCREDITATION CARDS

50 euro for each on-site approved additional requested accreditation card.

REPLACEMENT OF ATHLETES

In case an athlete needs to be replaced after the deadline, this can be done maximum 48 hours before the draw will take place. A fee of 100 euro is applicable.

EXTRA COACHES

50 euro for each coach exceeding the 1:5 ratio.

REPLACEMENT OF ACCREDITATION CARD

25 euro for each replacement and printing request of accreditation cards.

PROTEST FEE

200 euro. In case of an official protest submitted according to WT Rules, a non-refundable 200 euro fee shall be paid. Make sure the protest form is used (attached at the end) and be aware that the protest is made in time.

23. PROOF OF PAYMENT

All teams are required to send proof of payment (copy of bank transfer) to finance@europetaekwondo.org within one (1) week after registration in TPSS or submit it at the registration appointment booking platform. European Taekwondo Union has the right to delete sport entries from teams that do not send proof of payment from the system in order for other athletes to register and to prevent 'ghost athletes'.



Any athlete registering on-line who does not take part in the competition and who has not been removed from the entry list before the deadline (4th May 2025), is liable for paying his/her entry-fee in full. (For any athlete not presenting at registration, his/her team or official will be liable for ensuring full payment has been received, prior to the team's participation). If a team does not show up at the event and has not requested a participation cancellation before the deadline, it will be requested to settle the payment of the entry fees in full (100%).

24. NO REFUND

European Taekwondo Union and/or the Organizing Committee do not refund entry fees paid.

26. FIELD OF PLAY REGULATIONS

By accepting a European Taekwondo Union accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at European Taekwondo Union events.

27. AWARDS

Individual awards

- 1st place – gold medal and certificate
- 2nd place – silver medal and certificate
- 3rd place – bronze medal and certificate
- 3rd place – bronze medal and certificate

Team Awards

Overall 1st, 2nd, 3rd Trophies will be presented.

28. ANTI-DOPING

- The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- Compulsory anti-doping tests will be carried out for selected medalists, while random tests will be conducted to the rest of the athletes. The WT and/or WADA may carry out random out-of-competition testing prior to the championships.
- TUE (Therapeutic Use Exemption)



Athletes who take any substance or medicine listed in the “Prohibited List” of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact tue@ita.sport to have it set up. Otherwise, please download the TUE Application Form [HERE](#) and once duly completed and signed, send it together with the required medical file to tue@ita.sport with copy to antidoping@worldtaekwondo.org by at least 30 days before the first competition day. 31. INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the event or any activities linked therewith.



It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organizing Committee before 4th May 2025. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

32. MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care (COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word. All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs. Each MNA, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Bulgaria before arrival to the venue.

33. ACCOMMODATION

Hotels are **not** mandatory.

34. VISA

Visa forms should be sent back to officebtfwt@gmail.com by **the 5th of May 2025, 23:59 CET**. Forms sent after the 5th of May 2025 will not be accepted for any reason. All wrong information provided (mistakes in names, document numbers, dates, etc.) – is the applicant's responsibility.

To get a visa invitation, you need to send:

1. Proof of registration in GMS.
2. Proof of accommodation via OC (mandatory).
3. Filled the Visa application form.
4. Provide passport copies to all visa applicants.

Please be informed that the OC cannot speed up visa applications or contact embassies on behalf of visa applicants.

If any applicant does not get your visa on time, the payments are not refundable at any time.

35. VENUE ACCESS

All accredited team members will have free entry.

Attendees under 7 years do not pay daily ticket, all other attendees over 8 years must purchase a daily ticket for 10 EUR/person at the venue gates.
